Terms of payment

Cash is payable on or before each delivery. Cheques are acceptable only providing details are given to Us for prior clearance.

Range and Availability

All Goods are offered subject to availability and Your order will be accepted when We allocate Goods to Your order. If Goods ordered are not available We will seek Your agreement to substitutes except for vintage changes when We will supply the new vintage unless you have previously specified otherwise.

Delivery

Delivery shall occur when the Goods arrive at the delivery address and are signed for by one of Your signatories shown on Your credit application form. It is Your responsibility to advise Us in writing of changes to Your authorised signatories. If You fail to take or make arrangements to accept delivery or collect the Goods 5 working days after delivery or collection is offered to You or if We are unable to deliver because of inadequate access or instructions, delivery shall be deemed and We may do any one or more of the following (without prejudice to any other right or remedy We may have):

- Make additional charges for failed delivery
- Store the Goods at Your risk and cost
- Invoice You for the Goods
- Terminate this contract without liability on Our part
- Recover from You all costs and losses incurred by Us

Prices

The price of the Goods shall be as stated in Our price list current at the date of delivery and unless otherwise agreed or stated is inclusive of VAT and duty. Discounts are granted and reviewed in Our sole discretion. Any discount level agreed will be based on Your annual turnover with Us subject to a minimum £7,500 per annum. Any discounts deductions or rebates agreed are only available if the price is paid by the Due Date. Prices quoted are applicable to the quantity delivery dates and information provided by You. If the order placed varies or delay is caused by Your instructions or lack of instructions we shall be entitled to adjust the price.

Sale or Return

Agreement must be reached between Us and You prior to each sale. We are able to accept up to 25% of the original order on a sale or return basis, subject to a minimum return value of £50.

Licensing Act

In accordance with the UK legislation, We will only supply alcohol to persons aged 18 years and over.

Force Majeure

Except as provided otherwise in these Terms We shall not be deemed to be in breach of contract nor liable for any delays or failures to perform any of Our obligations under this contract due to any cause beyond Our reasonable control.

Variations

All orders are accepted by Us only under these Terms, which may not be altered except with Our written agreement. Any contrary or additional terms unless so agreed are excluded.

If You are an individual or a group of individuals by signing above You agree that We may:

- Seek, hold and process any information obtained about You from You or third parties for the purpose of and as a result of this and any other applications or agreements You or Your company have with Us.
